**PUEBLO ROCKHOUNDS, INC. & COLUMBINE GEM AND MINERAL SOCIETY  
FIELD TRIP RULES, SAFETY, CLAIMS AND RELEASE OF LIABILITY DOCUMENT**

**Effective January 1, 2017:** With a 'one time signature', the signed member is signifying he/she will abide by the Field Trip Rules, Claims, Safety and Release of Liability Document each and every year he/she is a paid member of the club. Members will receive a copy of this document after they sign.

**FIELD TRIP RULES**

All field trips are open to members of the Pueblo Rockhounds and the Columbine Gem & Mineral Society. All participants are required to sign a current Field Trip Rules, Claims, Safety and Release of Liability Document. This document is also required for minor children (under the age of 18) of club members, signed by the parent or legal guardian. A member may bring a minor(s), not included in the member's membership, on a field trip providing the minor(s) parent or legal guardian completes and signs a Field Trip Rules, Claims, Safety and Release of Liability Document, listing the minor(s) name(s). In addition, the minor(s) must be under the supervision of the club member at all times. **ADULT GUESTS** are not permitted on field trips due to liability issues.

**MEMBERSHIP CARDS** serve as identification; carry it with you on field trips. Members are required to sign up for field Trips; notify the field trip leader(s) if they decide to not attend after signing up & if they need to leave the field trip site early.

**PETS** are not allowed on field trips on private property.

**RETURNING TO FIELD TRIP SITES:** When a field trip takes place on private property, club members may not return to the site without the explicit permission and authorization from the land or claim owner(s).

**COLLECTING:** Collecting specimens is for non-commercial personal use.

**CLAIMS**

**THE LAKE GEORGE CLAIMS** are maintained for the use and enjoyment of the Pueblo Rockhound Club members. The claims are designated as Hand Tools ONLY for exploration cuts, pits and trenches. Drive only on existing marked Forest Service Roads. Fill in non-productive pits and trenches and assist the club in filling in larger pits. Bring out all trash. Members familiar with the location and boundaries of the club claims may visit the claims on their own time and at their own risk.

**SAFETY**

**SAFETY is of utmost importance to the Pueblo Rockhounds. We want everyone to have fun, collect nice specimens and return home without any injuries. Please be aware of the following:**

**\*Slips, trips and falls:** Watch where you are walking or climbing. Steep slopes and ravines are especially hazardous. Rocks and roots protruding out of the ground are also potential hazards.

**\*Heavy lifting and prying:** Carry or pry what you are physically capable of without causing an injury. Collection bags become very heavy, make several trips to your car if need be. Watch how much you lift and your posture in doing so.

**\*Falling rocks:** Watch for falling rocks! Large cobbles and boulders may become loose and roll down or fall from walls and roofs of pits. Do not throw rocks of any size! That rock may hit a fellow rockhound. Watch out for collectors working next to, above or below you.

**\*Rockpicks, Hammers & Chisels:** Use in a safe manner according to manufacturer's recommendations. Avoid mushroomed chisel heads as the flared edges could become a dangerous projectile. Wear safety glasses or goggles as well as gloves. Do not pound on rockpick heads as they splinter on impact resulting in dangerous projectiles.

**\*Dehydration:** Water is important and is the best fluid to prevent dehydration on a field trip. A dry mouth is a sign of dehydration. Going too long without water could cause dehydration and a trip to the hospital.

**\*Snakes and other predators** are out and about and we are invading their home. Know what is behind that bush or rock. Rattlesnakes are very dangerous when surprised or stepped on. Watch where you walk or place your hands.

**\*Drive Safely:** Field trips may involve driving on difficult, primitive and unimproved roads in remote locations. It is your responsibility to determine your driving and navigation skills and if your vehicle can handle the road conditions encountered on the trip.

**\*Health Issues:** Field trips may involve extreme, unpredictable weather conditions, as well as hiking and collecting at high altitudes with limited oxygen. Be sure your physical condition can meet these challenges. In most cases, remote areas have no means of timely rescue and evacuation to medical facilities.

I understand that negligence means a failure to do an act that a reasonable, careful person would do, under the same similar circumstance, to protect himself, herself or others from injury or death.
